Tuition: Tuition is billed and is due by the 1st of each month. A \$10.00 per day fee is assessed to your account for unpaid tuition. However, special arrangements may be made with Little Lamb Scholastic Academy Inc. for payments on a bimonthly schedule if you have two or more students in the program. Little Lamb Scholastic Academy reserves the right to disenroll any child if payment is not received by the 3rd of each month. All tuition and fees must be paid by Tuition Express. (See enclosed form) If you choose not to utilize Tuition Express an additional \$25.00 processing fee will be added to your account monthly. _____ (Initial)

Late Pick-Up: A fee of \$2.00 per minute is assessed for late pick-up. After 6:15p.m. Little Lamb Scholastic Academy reserves the right to drop your child at the Chicago Police Department, 1830 W. Monterey. After three late pick-ups in one semester, Little Lamb Scholastic Academy reserves the right to disenroll your child. _____ (Initial)

Withdrawal: The obligation for full payment of tuition continues until the contract expires on June 15, 2007. Little Lamb Scholastic Academy reserves the right to withdraw a child and release the family of any financial obligation. The family must give Little Lamb Scholastic Academy a 30-day written mutual agreement dissolving the contract. Little Lamb Scholastic Academy maintains the right to enforce contractual agreement. If contract is broken client is responsible for paying all remaining tuition, fees, attorney fees and all court costs. _____ (Initial)

Absences: Tuition must be paid in full without deduction for absences of any duration or for any cause, and without substitution of other days of attendance as "make-up" days. This is necessary due to staffing and operational costs that are fixed. _____ (Initial)

Fine Arts: A 61-key piano/keyboard must be purchased by the parent(s) by the 1st day of school for Pre-K and Kindergarten students for their lesson practice at home.
